In compliance with Article 12 of the CVM Resolution No. 44, dated August 23, 2021, Antipodes hereby informs that the portfolios under its management have disposed a relevant shareholding in the secondary market, in certain common shares issued by Sendas Distribuidora Aa (Company).

The total position held within the Company totals to, sixty two million, two hundred and ninety-four thousand, five-hundred and twenty-six common shares (62,294,526), representing four point six per cent (4.60%) of all common shares issued by the Company (1,352,215,647).

This investment does not intend to influence a change in the composition of corporate control or a change in management structure within the company. Currently, Antipodes Partners Limited, does not intend acquire control or administration of the company.
