**Shareholding in Sendas Distribuidora S.A. now below 5%**

Ninety One UK Limited, registered with the Financial Conduct Authority in the United Kingdom (Firm Reference Number 122420), declares that it has disposed of shares, for and on behalf of discretionary managed portfolios/accounts, such that the total shareholding is now below the 5% disclosure threshold.

As at 6 July 2026, we held 67,210,844 shares (4.9999%) (ISIN BRASAIACNORO).

We do not hold any financial derivatives in Sendas Distribuidora S.A.

Of these shares, the exercise of voting rights over 29,753,790 shares (2.2134%) is retained by the underlying client(s), rather than by Ninety One UK Limited. We hold full investment discretion (to buy and sell) over all 67,210,844 shares.

The decrease in the shareholding aims solely at carrying out financial operations of our funds. We do not aim to alter the composition of control, or the administrative nature of the company.
