**DATA, HORA E LOCAL:** Aos 30 de abril de 2026, às 11h, realizaram-se, de forma exclusivamente digital, por meio da plataforma digital *Microsoft Teams*, nos termos da Resolução CVM nº 81, de 29 de março de 2022, conforme alterada (“**RCVM 81**”), as Assembleias Gerais Ordinária e Extraordinária da B3 S.A. – Brasil, Bolsa, Balcão (“**Companhia**”), sendo consideradas como realizadas na sede social da Companhia (“**Assembleias Gerais**”).

**CONVOCAÇÃO:** As Assembleias Gerais foram convocadas por meio dos editais publicados nos dias 30, 31 de março e 01 de abril de 2026, no Jornal Valor Econômico, edição de São Paulo (respectivamente nas páginas E11, E2 e E6, do jornal impresso e em seu *website*), em cumprimento ao disposto no artigo 124 da Lei nº 6.404, de 15 de dezembro de 1976, conforme alterada (“**Lei das S.A.**”).

**PUBLICAÇÕES:** O Relatório da Administração, as Demonstrações Financeiras, acompanhadas do Parecer dos Auditores Independentes elaborado pela Deloitte Touche Tohmatsu Auditores Independentes Ltda., referentes ao exercício social findo em 31 de dezembro de 2025 e os Pareceres do Comitê de Auditoria e do Conselho Fiscal foram publicados, em 27 de fevereiro de 2026, no Jornal Valor Econômico, edição de São Paulo (páginas H01 a H09 do jornal impresso e em seu *website*). Todos os documentos relacionados às matérias a serem deliberadas nestas Assembleias Gerais, incluindo a Proposta da Administração e Manual para Participação, foram disponibilizados aos acionistas nos *websites* da Companhia ([ri.b3.com.br](http://ri.b3.com.br)) e da Comissão de Valores Mobiliários ([www.cvm.gov.br](http://www.cvm.gov.br)) (“**Documentos das Assembleias Gerais**”).

**PRESENÇA E INSTALAÇÃO:** Presentes em Assembleia Geral Ordinária os acionistas representando 73,18% do capital social votante da Companhia, e, em Assembleia Geral Extraordinária, acionistas representando 78,38% do capital social votante da Companhia, conforme presenças registradas por meio da plataforma digital disponibilizada pela Companhia, e pelos Boletins de Voto a Distância recebidos através do depositário central, do escriturador e do custodiante e diretamente pela Companhia, cumprindo-se o quórum legal para a realização das Assembleias Gerais. Registrou-se, ainda, a presença de membros da Administração da Companhia, os(as) Srs(as). Caio Ibrahim David, Presidente do Conselho de Administração da Companhia, Gilson Finkelsztain, Diretor Presidente, André Veiga Milanez, Diretor Executivo Financeiro, Administrativo e de Relações com Investidores, Silvia Maria de Almeida Bugelli Valença, Diretora Executiva Jurídica, Cristina Anne Betts, Conselheira de Administração e Coordenadora do Comitê de Auditoria, Maria Luiza Lage de Mattos Levi, Membro Externo e Especialista Financeira do Comitê de Auditoria, e André Coji, Coordenador do Conselho Fiscal, assim como da Sra. Renata Caffaro, Diretora de Pessoas e Comunicação

Interna, e do Sr. Dario Ramos da Cunha, representante da Deloitte Touche Tohmatsu Auditores Independentes Ltda.

**MESA:** Presidiu os trabalhos o Sr. **Caio Ibrahim David**, Presidente do Conselho de Administração da Companhia, tendo sido indicado para secretariar as Assembleias Gerais, o Sr. **Gilson Finkelsztain**, Diretor Presidente da Companhia, nos termos do §7º do artigo 12 do Estatuto Social da Companhia.

**ORDEM DO DIA: I – Em Assembleia Geral Ordinária:** (1) Deliberar sobre as contas dos administradores e as Demonstrações Financeiras relativas ao exercício social encerrado em 31/12/2025; (2) Deliberar sobre a destinação do lucro líquido do exercício social encerrado em 31/12/2025; (3) Fixar o limite da remuneração global dos administradores da Companhia para o exercício social de 2026, conforme detalhado na Proposta da Administração; (4) Na hipótese de haver pedido válido de instalação do Conselho Fiscal, eleger os seus membros efetivos e suplentes; e (5) Na hipótese de haver eleição do Conselho Fiscal, fixar a remuneração dos membros eleitos para o exercício social de 2026; e **II – Em Assembleia Geral Extraordinária:** (1) Deliberar sobre a alteração da redação do inciso II do artigo 3º do Estatuto Social da Companhia, referente ao objeto social, para incluir atividade complementar de representação digital de valores mobiliários, títulos, direitos, ativos financeiros e/ou outros tipos de ativos, sem alteração do segmento de atuação da Companhia, nem de suas atividades principais; (2) Deliberar sobre a alteração da redação do artigo 5º do Estatuto Social da Companhia, referente ao capital social, para refletir o cancelamento de ações, aprovado pelo Conselho de Administração em 26/02/2026, passando o capital social, atualmente dividido em 5.266.500.000 ações ordinárias, a ser dividido em 5.046.500.000 ações ordinárias, todas sem valor nominal, sem alteração do valor do capital social; (3) Consolidar o Estatuto Social da Companhia, de forma a refletir as alterações acima indicadas; (4) Ratificar a nomeação da empresa especializada Grant Thornton Auditoria e Consultoria Ltda., inscrita no CNPJ sob o nº 13.045.248/0001-10, como responsável pela elaboração do laudo de avaliação a valor contábil do patrimônio líquido da Datastock Tecnologia e Serviços Ltda. (“Datastock” ou “Incorporada”) para a sua incorporação pela Companhia (“Laudo de Avaliação”); (5) Deliberar sobre o Laudo de Avaliação; (6) Examinar, discutir e deliberar sobre os termos e condições do protocolo e justificação da incorporação da Incorporada pela Companhia, celebrado em 27/03/2026, entre a administração da Companhia e da Incorporada (“Incorporação” e “Protocolo e Justificação”, respectivamente); (7) Deliberar sobre a Incorporação proposta, com a consequente extinção da Incorporada, nos termos do Protocolo e Justificação; e (8) Autorizar a Administração da Companhia a praticar e assinar todos os atos necessários para formalizar a Incorporação e implementar as deliberações tomadas.

**PROCEDIMENTOS INICIAIS:** Foram prestados os esclarecimentos necessários acerca dos procedimentos para a participação e manifestação dos acionistas durante as Assembleias Gerais, nos termos da Resolução CVM 81. Nenhum dos acionistas participantes manifestou interesse em alterar as instruções de voto enviadas nos Boletins de Voto a Distância.

**LEITURA DOS DOCUMENTOS E LAVRATURA DA ATA:** Os acionistas presentes dispensaram a leitura dos Documentos das Assembleias Gerais, assim como do Mapa de Votação Sintético Consolidado, divulgado ao mercado em 28/04/2026, os quais ficaram à disposição para consulta dos acionistas, registrando-se a lavratura da presente ata na forma de sumário dos fatos ocorridos e tendo sido aprovada, por unanimidade dos acionistas presentes,

a sua publicação com omissão das assinaturas dos acionistas, conforme faculta os §§1º e 2º do artigo 130 da Lei das S.A.

**DELIBERAÇÕES:** Em prosseguimento aos trabalhos, os acionistas participantes das Assembleias Gerais deliberaram conforme abaixo, com a abstenção de voto dos acionistas legalmente impedidos:

**I – Em Assembleia Geral Ordinária:**

(1) Aprovar, pela maioria dos acionistas presentes, sem emendas ou ressalvas, tendo sido computados 3.085.599.953 votos a favor; 7.333.431 votos contrários; e 573.840.102 abstenções, as contas dos administradores e as respectivas Demonstrações Financeiras, relativas ao exercício social encerrado em 31/12/2025, acompanhadas das notas explicativas, do relatório da Deloitte Touche Tohmatsu Auditores Independentes Ltda., dos Pareceres do Comitê de Auditoria e do Conselho Fiscal.

(2) Aprovar, pela maioria dos acionistas presentes, sem emendas ou ressalvas, tendo sido computados 3.591.927.507 votos a favor; 10.185 votos contrários; e 74.835.794 abstenções, a destinação do lucro líquido do exercício social encerrado em 31/12/2025, nos seguintes termos: (i) R\$ 229.281.053,29, para a reserva legal; (ii) R\$ 3.024.000.000,00, aos acionistas da Companhia, sob a forma de juros sobre o capital próprio, sendo que, desse total, R\$ 2.274.000.000,00 já foram pagos ao longo do exercício de 2025 e início do exercício de 2026, nos termos do artigo 58 do Estatuto Social da Companhia; e (iii) o saldo remanescente, no montante de R\$ 1.335.344.715,04, para a reserva estatutária, nos termos do artigo 57, §1º do Estatuto Social da Companhia.

(3) Aprovar, pela maioria dos acionistas presentes, sem emendas ou ressalvas, tendo sido computados 3.496.772.406 votos a favor; 94.909.105 votos contrários; e 75.091.975 abstenções, a fixação do limite da remuneração global anual dos administradores da Companhia para o exercício social em curso, no valor de até R\$ 184.538.193,46, sem encargos, nos termos da Proposta da Administração.

(4) Registrar a instalação do Conselho Fiscal, solicitada por acionistas titulares de ações representativas de mais de 2% do total do capital social da Companhia, nos termos da Resolução CVM nº 70, de 22 de março de 2022, conforme alterada, e aprovar, por maioria dos acionistas presentes, sem emendas ou ressalvas, tendo sido computados 3.570.505.481 votos a favor; 23.428.111 votos contrários; e 72.839.894 abstenções, a eleição dos seguintes membros para o Conselho Fiscal da Companhia, com mandato até a assembleia geral ordinária que deliberar sobre as demonstrações financeiras do exercício social de 2026; (i) **ANDRÉ COJI**, brasileiro, casado, administrador de empresas, portador da Cédula de Identidade RG nº 8.782.472 SSP/SP e inscrito no CPF sob o nº 051.271.338-30, como **Conselheiro Fiscal Efetivo**; e **PAULO GIOVANNI CLAVER**, brasileiro, casado, contador, portador da Cédula de Identidade RG nº 14.102.834-8 SSP/SP e inscrito no CPF sob o nº 116.013.878-81, como seu respectivo **Conselheiro Fiscal Suplente**; (ii) **STÂNIA LOPES MORAES**, brasileira, divorciada, contadora, portadora da Cédula de Identidade RG nº 4.277.742 SSP/MG e inscrita no CPF sob o nº 714.048.646-87, como **Conselheira Fiscal Efetiva**; e **ANGELA APARECIDA SEIXAS**, brasileira, divorciada, contadora, portadora da Cédula de Identidade RG nº 11.769.058-2 SSP/SP e inscrita no CPF sob o nº 011.500.868-31, como sua respectiva **Conselheira Fiscal Suplente**; e (iii) **GUSTAVO PACHECO LUSTOSA**, brasileiro, casado,

geólogo, portador da Cédula de Identidade RG nº 12.889.121 SSP/DF e inscrito no CPF sob o nº 524.258.861-68, como **Conselheiro Fiscal Efetivo**; e **MARIA PAULA SOARES ARANHA**, brasileira, solteira, administradora de empresas, portadora da Cédula de Identidade RG nº 7.779.372-9 SSP/SP e inscrita no CPF sob o nº 035.859.048-58, como sua respectiva **Conselheira Fiscal Suplente**; todos com endereço comercial na Praça Antônio Prado, 48, 7º andar, Centro, São Paulo – SP, CEP: 01010-010. Consignou-se que os membros eleitos para o Conselho Fiscal declararam e comprovaram o atendimento às condições legais de elegibilidade, mediante a apresentação dos documentos exigidos pelo artigo 162 da Lei das S.A., os quais foram recebidos e arquivados pela Companhia.

(5) Aprovar, pela maioria dos acionistas presentes, sem emendas ou ressalvas, tendo sido computados 3.566.156.445 votos a favor; 3.069.119 votos contrários; e 97.547.922 abstenções, a fixação da remuneração dos membros do Conselho Fiscal da Companhia para o exercício social em curso, no valor de até R\$ 681.007,20, sem encargos, nos termos da Proposta da Administração.

## **II – Em Assembleia Geral Extraordinária:**

(1) Aprovar, pela maioria dos acionistas presentes, sem emendas ou ressalvas, tendo sido computados 3.852.329.924 votos a favor; 109.584 votos contrários; e 74.851.780 abstenções, a alteração da redação do inciso II do artigo 3º do Estatuto Social da Companhia, referente ao objeto social, para incluir atividade complementar de representação digital de valores mobiliários, títulos, direitos, ativos financeiros e/ou outros tipos de ativos, sem alteração do segmento de atuação da Companhia, nem de suas atividades principais. Essa alteração não modifica o segmento de atuação ou as atividades preponderantes da Companhia, razão pela qual não será concedido direito de recesso aos acionistas dissidentes. Face à alteração ora aprovada, o inciso II do artigo 3º do Estatuto Social da Companhia passará a vigorar com a seguinte redação:

*“Artigo 3º. (...)*

*II – Operação e manutenção de ambientes ou sistemas adequados à realização de negócios, incluindo compras e vendas, leilões e registro de operações envolvendo valores mobiliários, títulos, direitos e ativos financeiros ou quaisquer outros tipos de ativos, bem como a representação digital dos referidos ativos ou de sua propriedade, no mercado de bolsa e no mercado de balcão organizado;”*

(2) Aprovar, pela maioria dos acionistas presentes, sem emendas ou ressalvas, tendo sido computados 3.852.439.517 votos a favor; 6.927 votos contrários; e 74.844.844 abstenções, a alteração da redação do artigo 5º do Estatuto Social da Companhia, referente ao capital social, para refletir o cancelamento de ações mantidas em tesouraria, aprovado em reunião do Conselho de Administração realizada em 26/02/2026, passando o capital social, atualmente dividido em 5.266.500.000 ações ordinárias, a ser dividido em 5.046.500.000 ações ordinárias, todas sem valor nominal, sem alteração do valor do capital social. Face à alteração ora aprovada, o artigo 5º do Estatuto Social da Companhia passará a vigorar com a seguinte redação:

*“Artigo 5º. O capital social da Companhia é de R\$ 12.898.655.563,88, integralizado e dividido em 5.046.500.000 de ações ordinárias, todas nominativas e sem valor nominal, sendo vedada a emissão de ações preferenciais e de partes beneficiárias.”*

**(3)** Aprovar, pela maioria dos acionistas presentes, sem emendas ou ressalvas, tendo sido computados 3.852.436.462 votos a favor; 6.560 votos contrários; e 74.848.266 abstenções, a consolidação do Estatuto Social da Companhia, de forma a refletir as alterações aprovadas nos itens (1) e (2) acima, conforme Anexo II à presente ata.

**(4)** Aprovar, pela maioria dos acionistas presentes, sem emendas ou ressalvas, tendo sido computados 3.852.421.932 votos a favor; 8.071 votos contrários; e 74.861.285 abstenções, a ratificação da nomeação da empresa especializada Grant Thornton Auditoria e Consultoria Ltda., inscrita no CNPJ sob o nº 13.045.248/0001-10, como responsável pela elaboração do laudo de avaliação a valor contábil do patrimônio líquido da Datastock Tecnologia e Serviços Ltda. (“Datastock” e “Laudo de Avaliação”, respectivamente).

**(5)** Aprovar, pela maioria dos acionistas presentes, sem emendas ou ressalvas, tendo sido computados 3.852.416.501 votos a favor; 11.681 votos contrários; e 74.863.106 abstenções, o Laudo de Avaliação da Datastock, o qual passa a integrar a presente ata como Anexo III.

**(6)** Aprovar, pela maioria dos acionistas presentes, sem emendas ou ressalvas, tendo sido computados 3.852.417.507 votos a favor; 11.695 votos contrários; e 74.862.086 abstenções, os termos e condições do Protocolo e Justificação de Incorporação da Datastock, o qual passa a integrar a presente ata como Anexo IV.

**(7)** Aprovar, pela maioria dos acionistas presentes, sem emendas ou ressalvas, tendo sido computados 3.852.418.826 votos a favor; 10.382 votos contrários; e 74.862.080 abstenções, a incorporação da Datastock pela Companhia, sem aumento de capital e sem emissão de novas ações pela Companhia, com efeitos a partir do dia 01 de maio de 2026 e com a consequente extinção da sociedade incorporada, nos termos do Protocolo e Justificação aprovado (“Incorporação”); e

**(8)** Aprovar, pela maioria dos acionistas presentes, sem emendas ou ressalvas, tendo sido computados 3.852.419.367 votos a favor; 11.735 votos contrários; e 74.860.186 abstenções, a autorização da administração da Companhia a praticar e assinar todos os atos necessários para formalizar a Incorporação e implementar as deliberações tomadas.

**ENCERRAMENTO:** Nada mais foi tratado. O Presidente das Assembleias Gerais declarou encerrados os trabalhos e os suspendeu pelo tempo necessário à lavratura desta ata, que, foi lida, aprovada e assinada pelo Presidente e Secretário da Mesa, considerando-se, para todos os efeitos legais, subscrita pelos acionistas que participaram pelo meio digital e por aqueles que enviaram os Boletins de Voto a Distância, nos termos dos §§1º e 2º do artigo 47 da RCVM 81.
