1. DATA, HORA E LOCAL: Aos 30 dias do mês de abril de 2025, às 11:00 horas, na sede social do Banco BTG Pactual S.A., localizada na Praia de Botafogo, nº 501, 6º andar, Torre Corcovado, Auditório, na Cidade do Rio de Janeiro, Estado do Rio de Janeiro, CEP 22.250-040 (“Banco BTG Pactual” ou “Companhia”).

2. CONVOCACÃO: Os Editais de Convocação foram devidamente publicados nos dias 28, 29, 30, 31 de março e 1º de abril de 2025, no jornal Diário Comercial – RJ. Os demais documentos necessários ao exame das matérias constantes da Ordem do Dia foram colocados à disposição dos acionistas na sede social da Companhia, bem como foram encaminhados à Comissão de Valores Mobiliários (“CVM”) e à B3 S.A. – Brasil, Bolsa, Balcão, em cumprimento ao artigo 124 da Lei nº 6.404, de 15 de dezembro de 1976, conforme alterada (“Lei das S.A.”) e ao disposto nos artigos 11 e 12 da Resolução CVM nº 81, de 29 de março de 2022.

3. QUÓRUM DE INSTALAÇÃO E PRESENÇA: A Assembleia Geral Ordinária (“AGO”) foi instalada considerando a presença de acionistas representando mais de 1/4 (um quarto) do capital votante da Companhia, percentual superior ao exigido por lei, conforme assinaturas apostas no Livro de Presença de Acionistas. Presentes ainda os administradores da Companhia, bem como o representante dos auditores independentes, a PricewaterhouseCoopers Auditores Independentes S.S., e o membro qualificado do Comitê de Auditoria, não havendo Conselho Fiscal instalado.

4. COMPOSIÇÃO DA MESA: Os trabalhos foram presididos pela Sra. Maria Luisa Franchi Ferreira, e secretariados pelo Sr. Reinaldo Garcia Adão.

5.1. ORDEM DO DIA: (i) Deliberação sobre as Demonstrações Financeiras relativas ao exercício social encerrado em 31 de dezembro de 2024, tomando conhecimento do Relatório da Administração, do Relatório dos Auditores Independentes e dos Resumos dos Relatórios do Comitê de Auditoria; (ii) Deliberar sobre a destinação do lucro líquido do exercício social encerrado em 31 de dezembro de 2024; (iii) Deliberar sobre a eleição dos membros do Conselho de Administração; e (iv) Deliberar sobre a fixação do limite de valor da remuneração global anual dos administradores para o exercício social de 2025.

6. DELIBERAÇÕES: Os acionistas presentes à AGO tomaram as seguintes deliberações, por maioria dos votos presentes, na forma da Ordem do Dia constante do Edital

de Convocação da presente AGO, bem como (i) Dispensaram a leitura do Mapa Sintético de Votação Consolidado dos votos proferidos por meio de Boletins de Voto à Distância, divulgado ao mercado em 28 de março de 2025 e colocado à disposição dos acionistas para consulta; (ii) Aprovaram a lavratura desta Ata de AGO em forma de sumário, na forma do artigo 130, parágrafo 1º da Lei das S.A.; e (iii) Autorizaram a publicação da presente Ata com omissão das assinaturas dos acionistas, na forma do artigo 130, Parágrafo 2º da mesma lei.

6.1. Aprovar, pela maioria dos votos dos presentes, conforme identificado no mapa final sintético consolidado de votação constante do Anexo I, inclusive com as devidas abstenções dos acionistas, o relatório e as contas da administração, bem como as demonstrações financeiras da Companhia e suas notas explicativas, além do parecer dos auditores independentes, relativos ao exercício social encerrado em 31 de dezembro de 2024, os quais foram publicados em 14 de fevereiro de 2025 no Diário Comercial – RJ.

6.2. Aprovar, pela maioria dos votos dos presentes, conforme identificado no mapa final sintético consolidado de votação constante do Anexo I, inclusive com as devidas abstenções dos acionistas, a destinação do lucro líquido do exercício, no valor de R\$ 11.789.387.000,00 (onze bilhões, setecentos e oitenta e nove milhões, trezentos e oitenta e sete mil reais), nos termos do Estatuto Social da Companhia, na forma abaixo:

- a. R\$ 3.269.818.000,00 (três bilhões, duzentos e sessenta e nove milhões, oitocentos e dezoito mil reais) destinados ao pagamento de juros sobre capital próprio;
- b. R\$ 351.966.000,00 (trezentos e cinquenta e um milhões, novecentos e sessenta e seis mil reais) destinados à reserva legal; e
- c. R\$ 8.167.603.000,00 (oito bilhões, cento e sessenta e sete milhões, seiscentos e três mil reais) destinados às reservas estatutárias.

6.3. Aprovar, pela maioria dos votos dos presentes, conforme identificado no mapa final sintético consolidado de votação constante do Anexo I, inclusive com as devidas abstenções dos acionistas, a eleição dos seguintes membros para compor o Conselho de Administração da Companhia para o mandato de 01 (um) ano, estendendo-se até a posse dos novos conselheiros que serão eleitos na Assembleia Geral Ordinária de 2026: (i) para o cargo de Presidente do Conselho de Administração, o Sr. **ANDRÉ SANTOS ESTEVES**, brasileiro, analista de sistemas, casado pelo regime de separação total de bens, portador da cédula de identidade nº 77670222 expedida pelo IFP/RJ, e inscrito no CPF sob o nº 857.454.487-68, com escritório na Cidade e Estado de São Paulo, na Avenida Brigadeiro Faria Lima, nº 3.477, 12º andar, CEP: 04.538-133; (ii) para o cargo de Vice-Presidente do Conselho de Administração, o Sr. **JOHN HUW GWILI JENKINS**, inglês, bancário, casado, portador do passaporte nº 548217800 (Reino Unido), inscrito no CPF sob o nº 234.539.518-40, com

6.3.1. Os Conselheiros ora eleitos declaram sob as penas da lei que não estão impedidos de exercer a administração da Companhia, por lei especial, ou em virtude de condenação criminal, ou por encontrar-se sob os efeitos dela, ou de penas que vedem, ainda que temporariamente, o acesso a cargos públicos, ou por crime falimentar, de prevaricação, peita ou suborno, concussão, peculato ou contra a economia popular, contra o sistema financeiro nacional, contra as normas de defesa da concorrência, contra as relações de consumo, a fé pública ou a propriedade, dessa forma não estando incorso em quaisquer dos crimes previstos em lei que o impeça de exercer a atividade mercantil, estando cientes do disposto no artigo 147 da Lei das S.A.; bem como declaram que se encontram livres e desimpedidos para o exercício de suas atribuições, e preenchem todas as condições previstas na Resolução nº 4.970, do Conselho Monetário Nacional, de 1º de setembro de 2022.

6.3.2. Os Conselheiros ora eleitos deverão tomar posse em seus cargos em até 30 (trinta) dias contados da respectiva homologação pelo Banco Central do Brasil, mediante assinatura de termo de posse no livro próprio.

6.4. Aprovar, pela maioria dos votos dos presentes, conforme identificado no mapa final sintético consolidado de votação constante do Anexo I, inclusive com as devidas abstenções dos acionistas, a remuneração global anual da Administração da Companhia, cujo valor líquido de encargos sociais e da remuneração referente à participação em comitês será de até R\$ 30.000.000,00 (trinta milhões de reais).

6.4.1. Consignar que a remuneração global anual da Administração da Companhia, incluindo encargos sociais e remuneração decorrente da participação em comitês corresponde ao valor máximo de R\$ 30.000.000,00 (trinta milhões de reais), conforme detalhado no Anexo V da Proposta de Administração da Companhia - item 8.2 do Formulário de Referência, divulgada em 28 de março de 2025.

5. ENCERRAMENTO E ASSINATURAS: Nada mais havendo a ser tratado, foi oferecida a palavra a quem dela quisesse fazer uso e, como ninguém se manifestou, foram encerrados os trabalhos e suspensa a AGO pelo tempo necessário à lavratura desta ata, a qual, reaberta a sessão, foi lida e aprovada pelos membros da mesa e pelos acionistas presentes indicados no Anexo II à presente ata, na forma da lei.
