("Ofertante"), subsidiária integral da Ecopetrol S.A., informando sobre recebimento, pela Ofertante, de Ofício da Comissão de Valores Mobiliários ("CVM") por meio do qual a referida autarquia ratificou seu entendimento acerca da necessidade de realização de ajustes ao edital da Oferta Pública de Aquisição de Ações para Aquisição de Controle da BRAVA ("OPA" ou "Oferta" e "Edital").

A Ofertante manifestou que apresentará recurso ao Colegiado da CVM com a máxima celeridade, bem como que envidará todos os esforços para retomar a Oferta com a maior brevidade possível. Em razão da decisão de apresentar o recurso mencionado, a Oferta estará suspensa a partir da presente data até decisão final a ser proferida pelo Colegiado da CVM.

TO THE CVM BOARD OF COMMISSIONERS BY THE OFFEROR**

BRAVA ENERGIA S.A ("BRAVA" or "Company") (B3: BRAV3), pursuant to CVM Resolution No. 44, and further to the Material Facts of April 23, 2026, May 25, 2026, May 28, 2026 and June 8, 2026, and to the Notice to the Market of June 9, 2026, hereby informs its investors and the market in general that it received today, June 15, 2026, a notification from Ecopetrol Investimentos do Brasil Ltda. ("Offeror"), a wholly-owned subsidiary of Ecopetrol S.A., informing that the Offeror received an Official Letter from the Brazilian Securities Commission ("CVM") containing certain determinations for adjustments to the notice of the Voluntary Tender Offer for the Acquisition of Control of BRAVA ("Tender Offer" or "Offer" and "Offer Notice").

The Offeror has stated that it will promptly submit an appeal to the Board of the CVM and will use its best efforts to resume the Offer as soon as possible. As a result of the decision to submit such appeal, the Offer will be suspended as of the date hereof until a final decision is rendered by the Board of the CVM.

Finally, BRAVA reiterates its commitment to keep investors and the market in general duly informed of any material developments regarding the matters subject to this Material Fact.

Ecopetrol Investimentos do Brasil Ltda. (the "Offeror"), a wholly-owned subsidiary of Ecopetrol S.A. ("Ecopetrol"), hereby notifies **Brava Energia S.A.** (the "Company") that, in connection with the voluntary tender offer for the acquisition of control of the Company (*oferta pública voluntária parcial para aquisição de controle*) (the "Offer"), registered under No. CVM/SRE/AUT/OPA/AQC/2026/001, the Offeror has received an Official Letter from the technical staff of Brazilian Securities Commission (*Superintendência de Registros da Comissão de Valores Mobiliários – "CVM"*), demanding that the Offeror makes certain amendments to the Tender Offer Notice.

The Offeror respectfully disagrees with the CVM technical staff's determinations and, as a result, will file, opportunely within the shortest possible timeframe, an appeal to be reviewed by the CVM Board of Commissioners (*Colegiado da CVM*).

As a result, the Tender Offer will be suspended by the technical staff and shall be rescheduled in due course, subject to the outcome of the appeal.

The Offeror will make all efforts to ensure the Tender Offer is resumed within the shortest possible timeframe and is confident that the Tender Offer will be ultimately allowed to proceed as originally proposed. The Offeror undertakes to communicate to the market as soon as there is any relevant development.

The Offeror requests and authorizes the Company to publicly disclose the contents of this notification and to take all other actions required for compliance with the applicable regulations.
