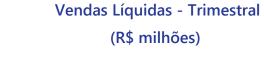

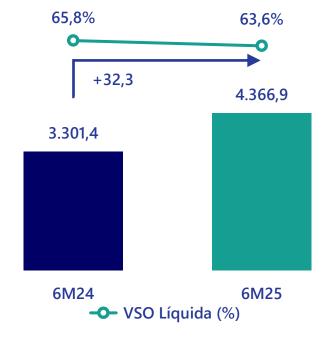


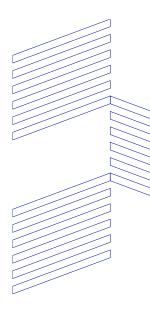






Vendas Líquidas - Acumulado (R\$ milhões)





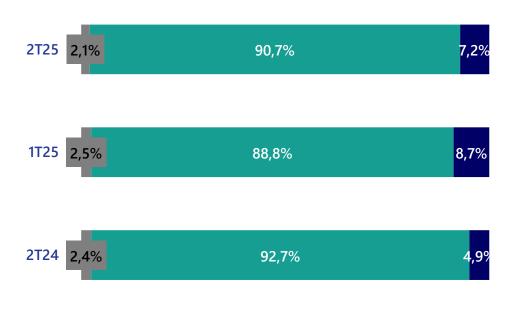


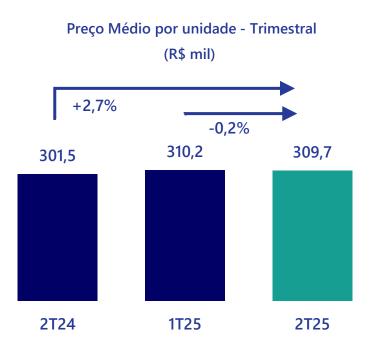

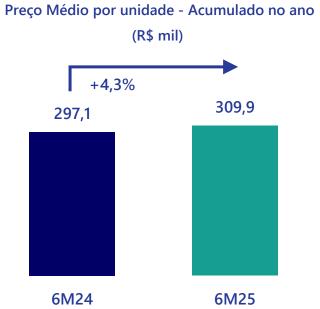

% de participação por faixa de preço



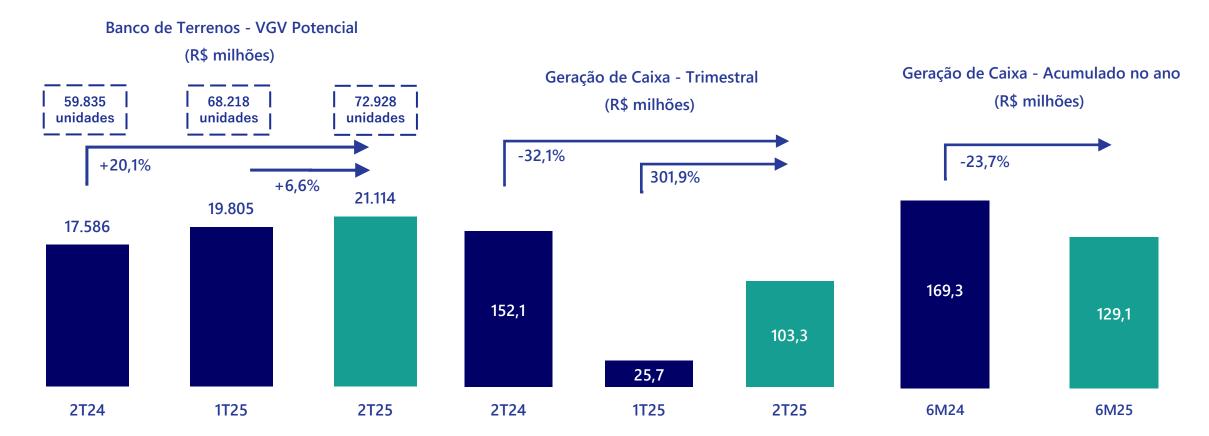

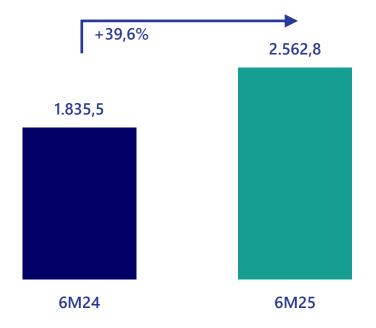


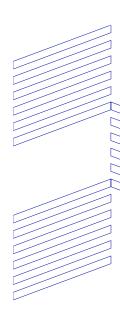






Receita líquida – Acumulado no ano (R\$ milhões)

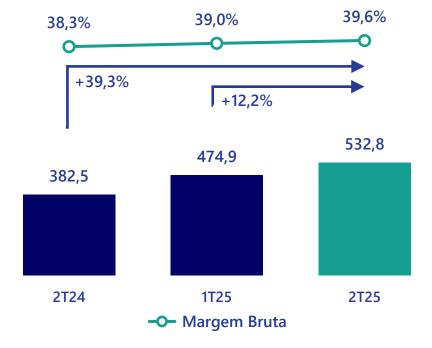




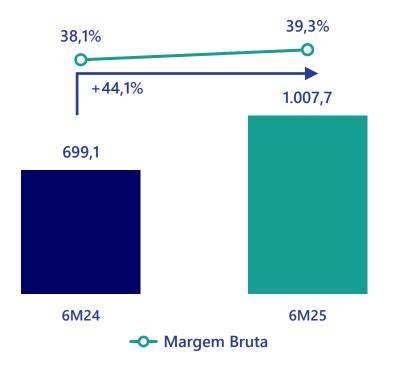








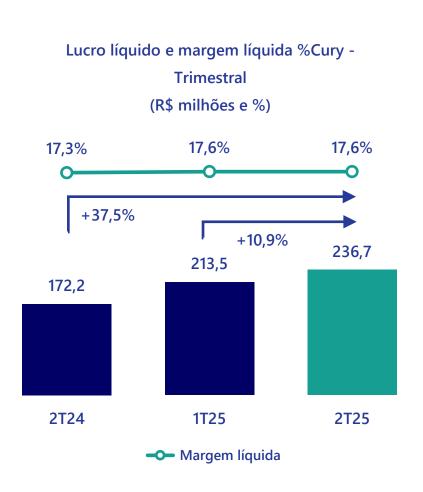
Lucro bruto e margem bruta – Acumulado no Ano (R\$ milhões e %)

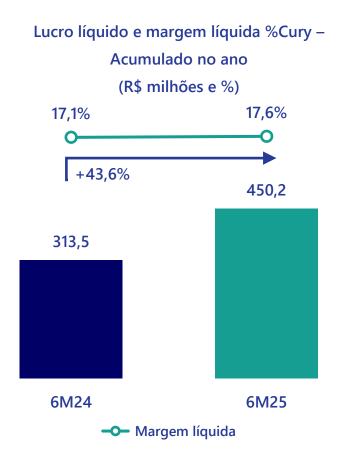

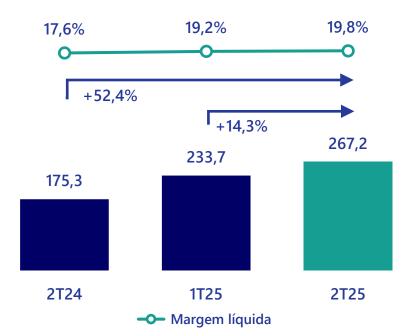


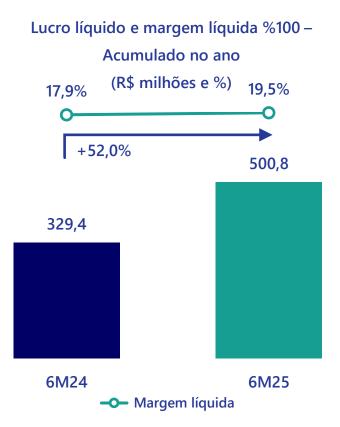






Lucro líquido e margem líquida %100 (R\$ milhões e %) - Trimestral

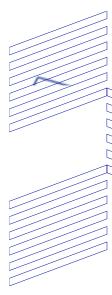






Gross profit and Gross margin - YTD (R\$ million and %)





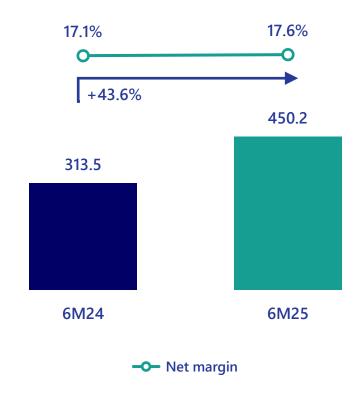


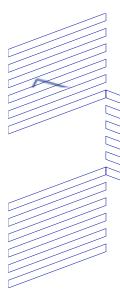


Net income and Net Margin %Cury - Quarterly (R\$ million and %)

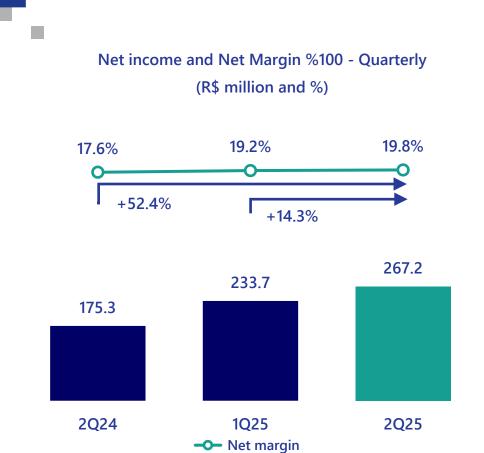


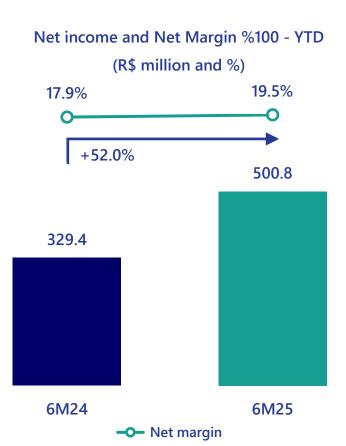
