

SUMMARY MINUTES OF THE FISCAL COUNCIL MEETING

Held on March 3, 2026

DATE, TIME, FORM AND PLACE: On March 3, 2026, at 9:30 a.m., at the registered office of Dexco S.A. (the "Company"), located at Avenida Paulista, No. 1.938, 5th floor, in the City of São Paulo, State of São Paulo, with participation by videoconference permitted pursuant to Article 26.4 of the Company's Bylaws and Article 5 of the Internal Rules of the Fiscal Council of Dexco S.A. (the "Company").

ATTENDANCE: All sitting members were present, namely: Guilherme Tadeu Pereira Júnior, João Batista Cardoso Sevilha and Geraldo Affonso Ferreira Filho. Mrs. Lucianna Raffaini Carvalho Costa, the Company's Chief Financial Officer, and Mr. Marcelo Palmeira, Accounting Manager, also attended the meeting.

SUMMARY OF THE MATTERS DISCUSSED:

Appointment of the Secretary of the Fiscal Council

Upon commencement of the meeting, the members of the Fiscal Council appointed Felipe Azevedo Pereira, an employee of the Company, to serve as Secretary of the Council.

Financial Statements for the Fiscal Year Ended December 31, 2025

The Fiscal Council examined the Financial Statements for the fiscal year ended December 31, 2025. In light of the clarifications provided by the independent auditors of Ernst & Young Auditores Independentes and by the Company's management, no additional clarifications were required. The Fiscal Council reviewed the proposal for the allocation of the results for fiscal year 2025 and opined that it is in a position to be submitted for consideration by the Annual Shareholders' Meeting.

Thereafter, the members agreed that the Fiscal Council will render its final opinion tomorrow regarding the Financial Statements for the fiscal year ended December 31, 2025, through the issuance of the corresponding opinion, to be approved by e-mail. Once approved, such opinion shall be filed with the Brazilian Securities and Exchange Commission (CVM), with B3 S.A. – Brasil, Bolsa, Balcão, and on the Company's website (www.dex.co/ri).
