We, the undersigned Nuveen LLC, hereby notify you that certain funds and accounts managed by our investment adviser subsidiaries, in the name of such accounts and funds, on August 1st, 2025, sold 3,363,200 common shares issued by the Company, holding, on that date, 26,945,600 common shares of the Company, representing approximately 4.76% of the total common shares issued by the Company and, therefore, reaching a percentage of less than 5.00% of the Company's share capital. 2. Thus, for compliance with Article 12 of Regulation No. 44 issued by the Brazilian Securities Commission (“CVM”) on August 23, 2021, as amended, Nuveen LLC hereby provides the following information: i. The registered office of Nuveen LLC is located at 730 Third Avenue New York, NY 10017, United States; ii. Nuveen LLC’s objective for the participation in the Company is as a passive investment. We do not have the objective of changing the controlling group or the administrative structure of the Company; iii. Nuveen LLC has not entered into any agreements or undertakings governing the exercise of voting rights or the purchase and sale of securities issued by the Company, other than agreements usually executed for purposes of asset management, pursuant to which certain of the clients of our investment adviser subsidiaries may exercise voting rights in respect of their investment portfolio. 3.
