I. Data, Hora e Local: Aos 25 dias do mês de abril de 2025, às 09h30, de modo exclusivamente digital, por meio do sistema eletrônico de participação a distância, nos termos do artigo 124, § 2º-A da Lei nº 6.404, de 15 de dezembro de 1976 (“Lei das S.A.”), e do artigo 5º, §2º, inciso I da Resolução da Comissão de Valores Mobiliários (“CVM”) nº 81, de 29 de março de 2022 (“Resolução CVM 81”). Nos termos do artigo 5º, §3º da Resolução CVM 81, esta Assembleia Geral Ordinária e Extraordinária (“Assembleia”) da Natura &Co Holding S.A. (“Companhia”) foi considerada como realizada na sede social da Companhia, localizada na Avenida Alexandre Colares, nº 1.188, sala A17, bloco A, Parque Anhanguera, CEP 05106-000, na cidade de São Paulo, Estado de São Paulo.

II. Convocação: Edital de Convocação publicado exclusivamente por meio do Sistema Empresas.NET, conforme previsto na Resolução CVM nº 166, de 1 de setembro de 2022.

III. Publicações Legais: O Relatório da Administração e as Demonstrações Financeiras da Companhia, acompanhadas do Relatório dos Auditores Independentes elaborado pela PricewaterhouseCoopers Auditores Independentes Ltda., relativos ao exercício social encerrado em 31 de dezembro de 2024, juntamente com o Parecer do Conselho Fiscal sobre as Demonstrações Financeiras, e o Relatório Anual do Comitê de Auditoria, de Gestão de Riscos e de Finanças foram publicados em 13 de março de 2025 no Sistema Empresas.Net, divulgados nos websites da Companhia, da CVM e da B3 S.A. – Brasil, Bolsa, Balcão (“B3”) e arquivados na sede social da Companhia.

IV. Quórum: Presentes acionistas titulares de ações ordinárias, nominativas e sem valor nominal representativas de (i) 81,47% do total de votos conferidos pelas ações com direito a voto da Companhia em Assembleia Geral Ordinária; e (ii) 83,45% do total de votos conferidos pelas ações com direito a voto da Companhia em Assembleia Geral Extraordinária, conforme registros do sistema eletrônico de participação a distância, nos termos do artigo 47, inciso III da Resolução CVM 81, e os boletins de voto a distância considerados válidos pela Companhia, nos termos do artigo 47, inciso II, da Resolução CVM 81.

V. Presença Legal: Presentes o Sr. Moacir Salzstein, Diretor de Governança Corporativa da Companhia, o Sr. Mozart Hasselman de Abreu Leite, representante da PricewaterhouseCoopers Auditores Independentes Ltda., o Sr. Gilberto Mifano, Coordenador do Comitê de Auditoria, de Gestão de Riscos e de Finanças, o Sr. Carlos Elder Maciel de Aquino, a Sra. Cristina Fontes Doherty e a Sra. Carla Alessandra Trematore, membros titulares do Conselho Fiscal, em atendimento ao disposto no §1º do artigo 134, caput do artigo 164 da Lei das S.A. e § 2º do artigo 31-B da Resolução CVM nº 23/2021.

VI. Composição da Mesa: Assumiu a presidência dos trabalhos o Sr. Moacir Salzstein, que convidou o Sr. Henrique da Silva Gordo Lang e a Sra. Daniela Pellegrino Anversa para secretariarem os trabalhos.

VII. Leitura dos Documentos e Lavratura da Ata: O mapa de votação sintético consolidado foi colocado à disposição para consulta, não tendo sido requerida a sua leitura. Foi aprovada pela unanimidade dos presentes a lavratura da presente ata em forma de sumário dos fatos ocorridos e a

sua publicação com omissão das assinaturas dos acionistas, na forma do artigo 130, §§ 1º e 2º, da Lei das S.A.

VIII. Ordem do Dia: Deliberar sobre:

Em Assembleia Geral Ordinária:

(1) tomar as contas dos administradores relativas ao exercício social encerrado em 31 de dezembro de 2024;

(2) examinar, discutir e votar as demonstrações financeiras relativas ao exercício social encerrado em 31 de dezembro de 2024, acompanhadas do relatório dos auditores independentes, do relatório do Comitê de Auditoria, de Gestão de Risco e de Finanças e do Parecer do Conselho Fiscal; e

(3) fixar a remuneração global dos administradores da Companhia, referente ao período até a data da assembleia geral ordinária em que os acionistas da Companhia deliberarem acerca das demonstrações financeiras do exercício social a ser encerrado em 31 de dezembro de 2025.

Em Assembleia Geral Extraordinária:

(1) deliberar sobre a eleição do Sr. Fábio Colletti Barbosa para o cargo de membro do Conselho de Administração da Companhia, por um prazo de mandato unificado com os demais membros do Conselho de Administração, a encerrar-se na data de realização da assembleia geral ordinária em que os acionistas da Companhia votarem acerca das demonstrações financeiras do exercício social a ser encerrado em 31 de dezembro de 2025; e

(2) aprovar (i) o “Protocolo e Justificação de Incorporação da Natura &Co Holding S.A. pela Natura Cosméticos S.A.” (“Protocolo e Justificação”); (ii) a ratificação da nomeação e da contratação da empresa de avaliação PricewaterhouseCoopers Auditores Independentes Ltda., como responsável pela elaboração do laudo de avaliação do patrimônio líquido da Companhia a ser incorporado pela Natura Cosméticos S.A. (“Laudo de Avaliação”); (iii) o Laudo de Avaliação; (iv) a incorporação da Companhia pela Natura Cosméticos S.A., nos termos e condições previstos no Protocolo e Justificação (“Incorporação”); e (v) a autorização para que a diretoria da Companhia possa praticar todos os atos e providências necessários à implementação da Incorporação.

VIII. Deliberações:

Em Assembleia Geral Ordinária:

(1) Foram aprovadas, por maioria dos votos proferidos, já considerando os impedimentos previstos em lei, tendo sido computados 924.955.500 votos a favor, 62.563 votos contrários e 197.578.621 abstenções, as contas dos administradores relativas ao exercício social encerrado em 31 de dezembro de 2024.

(2) Foram aprovadas, por maioria dos votos proferidos, tendo sido computados 924.705.485 votos a favor, 312.563 votos contrários e 197.578.636 abstenções, as demonstrações financeiras relativas ao exercício social encerrado em 31 de dezembro de 2024, acompanhadas do relatório dos auditores independentes, do relatório do Comitê de Auditoria, de Gestão de Risco e de Finanças e do Parecer do Conselho Fiscal; e

(3) Foi aprovada, por maioria dos votos proferidos, tendo sido computados 1.063.695.951 votos a favor, 54.864.952 votos contrários e 4.035.781 abstenções, a fixação da remuneração global dos

administradores, referente ao período até a data da assembleia geral ordinária em que os Acionistas votarem sobre as demonstrações financeiras relativas ao exercício social a ser encerrado em 31 de dezembro de 2025, considerando o período de maio de 2025 a abril de 2026, no valor total de até R\$ 71.384.030,79, incluindo remuneração fixa, variável e baseada em ações. Tendo em vista a aprovação da Incorporação, conforme item 2 da ordem do dia da Assembleia Geral Extraordinária, a remuneração ora aprovada será paga proporcionalmente até a data de consumação da Incorporação.

Em Assembleia Geral Extraordinária:

(1) Foi aprovada, por maioria dos votos proferidos, tendo sido computados 1.083.974.637 votos a favor, 61.183.746 votos contrários e 4.718.691 abstenções, a eleição do Sr. Fábio Colletti Barbosa, brasileiro, casado, administrador de empresas, portador da cédula de identidade (RG) nº 5.654.446/7, inscrito no CPF sob nº 771.733.258-20, com endereço profissional em Avenida Alexandre Colares, nº 1.188, sala A17, bloco A, Parque Anhanguera, CEP 05106-000, na Cidade de São Paulo, Estado de São Paulo, como membro não independente do Conselho de Administração da Companhia, com prazo de mandato unificado com os demais membros do Conselho de Administração. Registra-se que Conselheiro ora eleito informou à Companhia que preenche as condições prévias de elegibilidade previstas no artigo 147 da Lei das S.A. e na Resolução CVM nº 80/22 e que está em condições de firmar termo de posse e prestar as declarações exigidas nos termos do Anexo K da Resolução CVM nº 80/22.

(2) Foram aprovados, por maioria dos votos proferidos, tendo sido computados 1.146.929.915 votos a favor, 250.700 votos contrários e 2.696.459 abstenções, os seguintes atos e documentos:

- (i) o Protocolo e Justificação, na forma do Anexo II, ratificando sua assinatura;
- (ii) a ratificação da nomeação e da contratação da empresa de avaliação PricewaterhouseCoopers Auditores Independentes Ltda., como responsável pela elaboração do Laudo de Avaliação;
- (iii) o Laudo de Avaliação, anexo ao Protocolo e Justificação;
- (iv) a Incorporação; e
- (v) a autorização para que a Diretoria da Companhia possa praticar todos os atos e providências necessários à implementação da Incorporação.

Conforme estabelecido na Cláusula 16.2 do Protocolo e Justificação, a consumação da Incorporação ocorrerá em data a ser aprovada pelos Conselhos de Administração da Natura Cosméticos S.A. e da Companhia, em reunião realizada logo após a satisfação e verificação de todas as condições suspensivas previstas na Cláusula 16.1 do Protocolo e Justificação.

IX. Encerramento: Nada mais havendo a tratar, o Presidente agradeceu a presença de todos e deu por encerrados os trabalhos, suspendendo a Assembleia para que se lavrasse a presente ata, a qual, depois de lida, discutida e achada conforme, foi aprovada e assinada pela Mesa. A lista dos Acionistas presentes consta do Anexo I. Nos termos do artigo 47, §§1º e 2º da Resolução CVM 81, foram considerados presentes à Assembleia e signatários da ata os acionistas cujos boletins de voto a distância foram considerados válidos pela Companhia e os acionistas que registraram a sua presença no sistema eletrônico de participação a distância.
