REALIZADA EM 15 DE ABRIL DE 2026**

- 1. DATA, HORA E LOCAL:** Realizada em 15 de abril de 2026, às 15:00, na sede social da Raia Drogasil S.A. (“Companhia”), localizada na cidade de São Paulo, Estado de São Paulo, na Avenida Corifeu de Azevedo Marques, nº 3.097, Vila Butantã, CEP 05.339-900.
- 2. CONVOCAÇÃO:** Edital de Convocação foi publicado nas edições de 14, 16 e 17 de março de 2026 no jornal “O Estado de S. Paulo”, nas páginas B13, B4 e B23, respectivamente, com divulgação simultânea na página desse mesmo jornal na internet (“Edital de Convocação”). Nos termos do Aviso aos Acionistas divulgado pela Companhia em 14 de abril de 2026, a Companhia decidiu cancelar a Assembleia Geral Extraordinária convocada para o dia 15 de abril de 2026, que trataria da proposta de aprovação do Segundo Aditivo ao Plano de Outorga de Ações Restritas da Companhia aprovado em 15 de setembro de 2020, bem como da proposta de reforma e consolidação do seu estatuto social.
- 3. PRESENCAS:** Presentes na Assembleia Geral Ordinária acionistas representando 83,8% do capital votante, conforme (i) assinaturas apostas na “Lista de Presença de Acionistas”; e (ii) nos boletins de voto a distância considerados válidos pela Companhia, nos termos da Resolução CVM nº 81, de 29 de março de 2022 (“Resolução CVM 81”). Presentes, também, o Srs. Antonio Carlos Coelho e Flavio de Moraes Correia, representando a administração da Companhia, os Sr. Paulo Sérgio Buzaid Tohmé, representando o Conselho Fiscal da Companhia, e a Sra. Natacha Rodrigues dos Santos, representando a Deloitte Touche Tohmatsu Auditores Independentes.
- 4. MESA:** Presidente: Antonio Carlos de Freitas; e Secretário: Elton Flávio Silva de Oliveira.
- 5. ORDEM DO DIA:** (i) tomada de contas dos administradores, exame, discussão e votação das demonstrações financeiras relativas ao exercício social encerrado em 31 de dezembro de 2025, acompanhadas do Relatório da Administração, Relatório dos Auditores Independentes, publicados na edição do jornal “O Estado de São Paulo” do dia 05 de março de 2026, bem como do parecer do Conselho Fiscal e do Parecer do Comitê de Auditoria; (ii) destinação do lucro líquido do exercício social encerrado em 31 de dezembro de 2025; (iii) fixação do limite global da remuneração anual dos administradores da Companhia; (iv) fixação do número de membros do Conselho Fiscal da Companhia para o próximo mandato; (v) eleição dos membros efetivos do Conselho Fiscal e respectivos suplentes; e (vi) fixação da remuneração anual dos membros do Conselho Fiscal.
- 6. DELIBERAÇÕES:** Após a dispensa da leitura do mapa de votação consolidado dos votos proferidos por meio de boletins de voto a distância, o qual ficou disponível para consulta dos acionistas presentes, de acordo com a Resolução CVM 81, foi aprovada, por unanimidade de votos dos acionistas presentes, a lavratura da ata desta Assembleia Geral Ordinária em forma de sumário dos fatos

ocorridos, contendo apenas a transcrição das deliberações tomadas, sendo que as declarações e manifestações de voto apresentadas por escrito pelos acionistas foram numerados seguidamente, autenticados pela mesa e ficam arquivados na sede da Companhia, bem como foi aprovada a sua publicação com a omissão das assinaturas da totalidade dos acionistas, conforme faculta o artigo 130, parágrafos 1º e 2º, da Lei nº 6.404, de 15 de dezembro de 1976, conforme alterada (“Lei das S.A.”).

6.1 Ato contínuo, após exame e discussão das matérias constantes da Ordem do Dia, os acionistas deliberaram:

- (i) Aprovar, sem ressalvas, por maioria, tendo sido computados 1.293.677.840 votos a favor e 6.648 votos contrários e registradas 172.577.573 abstenções, incluindo as abstenções dos legalmente impedidos, as contas dos administradores e as demonstrações financeiras relativas ao exercício social encerrado em 31 de dezembro de 2025, acompanhadas do Relatório da Administração e do Relatório dos Auditores Independentes, publicados na edição do “O Estado de S. Paulo” em 05 de março de 2026, bem como do Parecer do Conselho Fiscal e do Parecer do Comitê de Auditoria;
- (ii) Aprovar, por maioria, tendo sido computados 1.463.037.223 votos a favor e 4.489 votos contrários e registradas 3.220.349 abstenções, a destinação do lucro líquido do exercício social encerrado em 31 de dezembro de 2025, no valor total de **R\$ 1.296.859.527,10**, nos termos da Proposta da Administração, e considerando as previsões legais e estatutárias, conforme segue:
 - (i) **R\$ 64.842.976,36**, equivalentes a 5% do lucro líquido do exercício, para a Reserva Legal;
 - (ii) **R\$ 536.000.000,00**, equivalentes ao montante total bruto de juros sobre o capital próprio aprovados em 2025 (a) nas reuniões do Conselho de Administração de (a.1.) 31 de março de 2025, no valor bruto de **R\$ 118.100.000,00**, correspondente à R\$ 0,068943352 por ação, sobre o qual é efetuada a dedução do imposto de renda na fonte, conforme aplicável, pagos aos acionistas em 01 de dezembro de 2025; (a.2.) 30 de junho de 2025, no valor bruto de **R\$ 131.800.000,00**, correspondente à R\$ 0,076940867 por ação, sobre o qual é efetuada a dedução do imposto de renda na fonte, conforme aplicável, pagos aos acionistas em 05 de dezembro de 2025, (a.3) 30 de setembro de 2025, no valor bruto de **R\$ 140.700.000,00** correspondente à R\$ 0,082136419 por ação, sobre o qual será efetuada a dedução do imposto de renda na fonte, conforme aplicável, a serem pagos aos acionistas até 30 de maio de 2026, sem acréscimo de correção monetária ou juros; e (b) na Assembleia Geral Extraordinária realizada em 28 de dezembro de 2025, no valor bruto de **R\$ 145.400.000,00**, correspondente à R\$ 0,084880137 por ação, sobre o qual será efetuada a dedução do imposto de renda na fonte, conforme aplicável, a serem pagos aos acionistas até 29 de maio de 2026, sem acréscimo de correção monetária ou juros; em todos os casos imputados pelo seu valor líquido ao dividendo obrigatório referente ao exercício social encerrado em 31 de dezembro de 2025;
 - (iii) **R\$ 130.000.000,00**, correspondente a R\$ 0,075890081 por ação, pagos aos acionistas em 29 de dezembro de 2025, referentes aos dividendos intercalares previamente aprovados pela Assembleia Geral Extraordinária realizada em 22 de dezembro de 2025, com base e à conta de lucros acumulados do exercício, conforme indicado nas Informações Financeiras Intermediárias Trimestrais da Companhia na data base de 30 de setembro de 2025, e imputados ao dividendo

obrigatório referente ao exercício social encerrado em 31 de dezembro de 2025; e **(iv) R\$ 582.681.250,18**, equivalente a 44,93% do resultado líquido do exercício, para a Reserva Estatutária prevista no artigo 21, alínea “c”, do Estatuto Social da Companhia;

- (iii)** Aprovar, por maioria, tendo sido computados 1.442.000.735 votos a favor e 19.721.859 votos contrários e registradas 4.539.467 abstenções, em conformidade com o §4º do artigo 5º do Estatuto Social da Companhia, a fixação do limite global da remuneração anual dos administradores da Companhia para o exercício social de 2026, no valor total líquido de até **R\$ 87.512.853,00**;
- (iv)** Aprovar, por maioria, tendo sido computados 1.463.031.196 votos a favor e 9.044 votos contrários e registradas 3.221.821 abstenções, a fixação do número de membros para compor o Conselho Fiscal da Companhia, nos termos do artigo 19 do Estatuto Social, em 4 (quatro) membros titulares e seus respectivos suplentes;
- (v)** Eleger os seguintes membros efetivos e respectivos suplentes para o Conselho Fiscal da Companhia, para mandato de 1 (um) ano que se encerrará na Assembleia Geral Ordinária a ser realizada em 2027: **(a)** em votação em separado, pelos acionistas minoritários, por maioria, tendo sido computados 10.311.173 votos, como membro titular, Sr. **Guilherme Bottrel Pereira Tostes**, brasileiro, contador, casado, portador da CRC RJ nº 08205800, inscrito no CPF/MF sob o nº 016.446.957-58, e, como seu suplente, Sr. **Jayme Sanches Neto**, brasileiro, contador, casado, portador da Cédula de Identidade RG nº 088625652 IFP-RJ, inscrito no CPF/MF sob o nº 025.945.167-32, ambos residentes e domiciliados na Avenida Rio Branco, 37, Grupo 203, Centro, Rio de Janeiro/RJ. Consigna-se que os candidatos João Martins Felcar, para membro titular, e Benilton Couto da Cunha, como respectivo suplente receberam 6.755.002 votos; e **(b)** em eleição geral, pelos demais acionistas da Companhia, por maioria, tendo sido computados 1.448.995.896 votos a favor, 192.127 votos contrários e registradas 7.863 abstenções, como membros titulares, os Srs. **Gilberto Lerio**, brasileiro, divorciado, contador, portador da Carteira de Identidade RG nº 4.370.494- 3 SSP/SP, inscrito no CPF/MF sob o nº 269.714.378- 53 e no CRC sob o nº 111.445/0- 9, residente e domiciliado na cidade de São Paulo, Estado de São Paulo, com endereço na Rua Funchal, 129, 1º Andar, Vila Olímpia, CEP 04551-060; **Paulo Sérgio Buzaid Tohmé**, brasileiro, casado, advogado, portador da Carteira de Identidade RG nº 11.334.025 SSP/SP, inscrito no CPF/MF sob o nº 143.925.478-84, residente e domiciliado na cidade de São Paulo, Estado de São Paulo, com endereço na Rua Doutor. - (vi) Aprovar, por maioria, tendo sido computados 1.459.455.563 votos a favor e 44.459 votos contrários e registradas 6.762.039 abstenções, a remuneração dos membros efetivos do Conselho Fiscal da Companhia para o exercício de 2026 em montante correspondente a 10,5% (dez vírgula cinco por cento) do valor da média da remuneração atribuída a cada Diretor da Companhia não computados benefícios, verbas de representação e participação nos lucros, nos termos do parágrafo 3º do artigo 162, da Lei das S.A.
