(B3: RAIZ4) ("Raízen" or "Company") in compliance with Article 12 of Brazilian Securities and Exchange Commission ("CVM") Resolution No. 44, dated August 23, 2021, as amended, hereby informs that it has received a correspondence from **Norges Bank** informing that it has acquired a relevant shareholding, with the acquisition of preferred shares, now managing a total of 68,761,954 (sixty-eight million, seven hundred sixty-one thousand, nine hundred fifty-four) shares, equivalent to 5.06% (five point zero six per cent) of the total preferred shares issued by the Company.

(I) Name and address of the relevant shareholder:

(II) The purpose of the acquisition and the interest is purely investment.

(III) On 24 September 2024 Norges Bank's holding in Raizen SA (ISIN: BRRAIZACNPR6) exceeded the 5% threshold and amounted to 68,761,954 preference shares or 5.06% based upon 1,358,936,900 total preference shares outstanding. The threshold crossing does not alter the control or the administrative structure of Raizen SA. Norges Bank does not have any other securities or derivatives referenced to shares held directly by Norges Bank.

(IV) Before crossing above the 5% threshold, Norges Bank held 67,938,704 preference shares in Raizen SA, equal to 4.995% of the total preference shares.

(V) No shareholders' agreement or contract regulating the right to vote or purchase and sale securities issued by the company exists.
