Prezados Senhores,

1. A Wellington Management Group LLP (“Wellington Management”) é uma *partnership* constituída no Estado de Delaware, que atua na área de gestão de investimentos.
2. Por meio da presente, informamos que clientes cujas contas sob gestão encontram-se sob nossa gestão discricionária adquiriram uma participação acionária relevante na Companhia de Saneamento Básico do Estado de São Paulo – SABESP.
3. Em cumprimento ao dever de divulgação previsto no artigo 12 da Instrução da Comissão de Valores Mobiliários (“CVM”) nº 358, de 3 de janeiro de 2002, conforme alterada (“Instrução CVM 358”), seguem abaixo todas as informações exigidas:
 - (i) Dados da Wellington Management: a Wellington Management tem sede à c/o Wellington Management Company LLP, 280 Congress Street, Boston, MA 02210, Estados Unidos;
 - (ii) Objetivo: nenhum dos clientes da Wellington Management pretende alterar o controle ou a estrutura administrativa da Companhia de Saneamento Básico do Estado de São Paulo – SABESP;
 - (iii) Participação: em **30 de março de 2026**, os clientes da Wellington Management detinham **35.897.672** ações ordinárias da Companhia de Saneamento Básico do Estado de São Paulo – SABESP, representando **5,09%** do total de ações ordinárias de emissão da Companhia;
 - (iv) Outros valores mobiliários da Companhia de Saneamento Básico do Estado de São Paulo – SABESP: a Wellington Management não tem conhecimento se seus clientes detêm posições em quaisquer outros valores mobiliários ou

instrumentos financeiros derivativos referenciados a ações da Companhia de Saneamento Básico do Estado de São Paulo – SABESP. Entendemos, contudo, que, ainda que detenham, tais debêntures conversíveis não seriam agregadas às participações ora reportadas, uma vez que as participações reportadas foram adquiridas sob nossa gestão discricionária;

- (v) Acordos de exercício de direito de voto: exceto pelos contratos de gestão firmados entre a Wellington Management e cada um de seus clientes, para fins de administração de ativos, nos termos dos quais, de modo geral, podemos exercer os direitos de voto relativos às carteiras de investimento desses clientes, não existe qualquer acordo ou contrato entre nós, de um lado, e parte ou a totalidade dos clientes que detêm a participação agregada ora reportada, de outro, que regule atuação conjunta ou arranjo similar no que se refere ao exercício dos direitos de voto ou à compra e venda de valores mobiliários emitidos pela Companhia de Saneamento Básico do Estado de São Paulo – SABESP.

Aguardamos a confirmação de que foi efetuada a devida comunicação à CVM.

2. Please be advised that clients whose managed accounts are under our discretionary management have acquired a relevant shareholding in Companhia de Saneamento Basico do Estado de Sao Paulo - SABESP.
3. In compliance with our disclosure duty under article 12 of Securities and Exchange Commission of Brazil ("CVM") Instruction No. 358 dated January 3, 2002 (as amended, "CVM Instruction 358"), the complete information required thereunder is as follows:
 - (i) Wellington Management' Particulars: Wellington Management has head office at c/o Wellington Management Company LLP, 280 Congress Street, Boston, MA 02210 ;
 - (ii) Objective: None of Wellington Management' clients intends to alter the control or administrative structure of Companhia de Saneamento Basico do Estado de Sao Paulo - SABESP.
 - (iii) Holding: as at **March 30, 2026**, Wellington Management' clients hold **35,897,672** of Companhia de Saneamento Basico do Estado de Sao Paulo - SABESP common shares and such holding represents **5.09%** of the common shares of Companhia de Saneamento Basico do Estado de Sao Paulo - SABESP in issue;
 - (iv) Other certain Companhia de Saneamento Basico do Estado de Sao Paulo - SABESP Securities: Wellington Management is not

aware whether its clients hold any positions in any other securities or derivative financial instruments referenced to Companhia de Saneamento Basico do Estado de Sao Paulo - SABESP shares. We understand, however, that even if they do, such convertible debentures would not be aggregated with any portion they own in the holdings hereby reported since these holdings were purchased under our discretionary management.

- (v) Voting Rights Agreements: Other than a managed account agreement entered into between us and each client for purposes of asset management pursuant to which, generally, we may exercise voting rights in respect of such client's investment portfolio, there is no agreement or contract between us, on the one hand, and part or all of the clients who own the aggregate holdings reported hereby, on the other, regulating any acting in concert or similar arrangement with respect to the voting rights or the purchase and sale of securities issued by Companhia de Saneamento Basico do Estado de Sao Paulo - SABESP.

We look forward to receiving confirmation that you have made the relevant reporting to the CVM.
