ATA DA ASSEMBLEIA GERAL EXTRAORDINÁRIA DE 28 DE AGOSTO DE 2026

1. DATA, HORÁRIO E LOCAL: A assembleia geral extraordinária da Companhia de Saneamento Básico do Estado de São Paulo – Sabesp ("Companhia") foi realizada no dia 28 de agosto de 2026, às 11:00 horas, de modo exclusivamente digital, por meio da Plataforma "Ten Meetings", com base na Resolução da Comissão de Valores Mobiliários ("CVM") nº 81, de 29 de março de 2022 ("Resolução CVM 81"), sendo considerada como realizada na sede da Companhia ("Assembleia").

2. CONVOCAÇÃO, PUBLICAÇÕES E DIVULGAÇÃO: A Assembleia foi convocada por meio de edital de convocação regularmente publicado, na forma do artigo 124 da Lei nº 6.404, de 15 de dezembro de 1976 ("Lei das S.A."), no jornal Valor Econômico, nos dias 29, 30 e 31 de julho de 2026, nas páginas E3, E2 e E3, respectivamente. Os documentos pertinentes às matérias constantes da ordem do dia, incluindo o edital de convocação e a proposta da administração, foram colocados à disposição dos acionistas, na sede da Companhia e divulgados nas páginas eletrônicas da CVM, da B3 S.A. – Brasil, Bolsa, Balcão ("B3") e da Companhia, nos termos da Lei das S.A. e da regulamentação da CVM aplicável.

3. PRESENÇA: Nos termos do artigo 6º do Estatuto Social da Companhia, é vedado a qualquer acionista ou grupo de acionistas (conforme definido no Estatuto Social), o exercício do direito de voto em número superior ao equivalente a 30% da quantidade total de ações em que se divide o capital social total votante da Companhia, independentemente da participação do acionista ou grupo de acionistas no capital social. Conforme verificado pelas presenças registradas por meio da Plataforma "Ten Meetings", nos termos da Resolução CVM 81, bem como pelos boletins de voto a distância válidos recebidos por meio da Central Depositária da B3, do agente escriturador das ações de emissão da Companhia, do custodiante dos acionistas e diretamente por meio da Plataforma "Ten Meetings", já considerada a referida restrição de voto, computou-se a presença de acionistas titulares de 2.781.010.830 ações ordinárias, todas nominativas, escriturais e sem valor nominal, de emissão da Companhia, representando aproximadamente 79,31% do capital social com direito a voto. Foi verificado, portanto, o quórum de 1/4 do capital social votante da Companhia, nos termos do artigo 125 da Lei das S.A., razão pela qual a presente Assembleia foi regularmente instalada, em primeira convocação, para deliberar sobre todos os itens previstos na ordem do dia. Presentes, ainda, Daniel Szlak, Diretor Financeiro e de Relações com Investidores; Maria Alicia Lima Peralta, Diretora Jurídica; e Gisomar Francisco de Bittencourt, Coordenador do Conselho Fiscal.

4. MESA: Os trabalhos foram presididos por Alexandre Gonçalves Silva e secretariados por Nair V. Saldanha.

5. ORDEM DO DIA: Reuniram-se os acionistas da Companhia para examinar, discutir e votar a respeito da seguinte ordem do dia:

I. Eleição dos membros do Conselho de Administração da Companhia, para mandato unificado com término na Assembleia Geral Ordinária que deliberar sobre as demonstrações financeiras do

exercício social a ser encerrado em 31 de dezembro de 2026;

II. Caracterização da qualidade de independente de Alexandre Gonçalves Silva, candidato a membro do Conselho de Administração nos termos das regras estabelecidas no Regulamento do Novo Mercado da B3 e na Resolução CVM nº 80, de 29 de março de 2022 ("Resolução CVM 80");

III. Caracterização da qualidade de independente de Gustavo Rocha Gattass, candidato a membro do Conselho de Administração, nos termos das regras estabelecidas no Regulamento do Novo Mercado da B3 e na Resolução CVM 80; e

IV. Caracterização da qualidade de independente de Mateus Affonso Bandeira, candidato a membro do Conselho de Administração, nos termos das regras estabelecidas no Regulamento do Novo Mercado da B3 e na Resolução CVM 80.

6. DELIBERAÇÕES: Preliminarmente, foi dispensada a leitura do edital de convocação e dos documentos relacionados às matérias a serem deliberadas na Assembleia, dada sua ampla divulgação. Foi dispensada, por unanimidade dos acionistas presentes, a leitura do mapa de votação sintético consolidado, em razão da prévia e ampla divulgação. Foi informado que a lavratura da presente ata será realizada na forma de sumário, nos termos do artigo 130, § 1º, da Lei das S.A., e do artigo 9º, § 4º, do Estatuto Social da Companhia. Foi aprovada, por unanimidade, a publicação desta ata com omissão das assinaturas dos acionistas, nos termos do artigo 130, § 2º, da Lei das S.A. Ato contínuo, foram tomadas as seguintes deliberações, sem quaisquer ressalvas ou restrições, cujos votos favoráveis, contrários e abstenções relativos às deliberações desta Assembleia encontram-se registrados no mapa de votação constante do **Anexo I** da presente ata:

IV. Aprovar, por maioria de votos dos acionistas presentes, a caracterização de **Mateus Affonso Bandeira** como membro independente do Conselho de Administração, nos termos das regras estabelecidas no Regulamento do Novo Mercado da B3 e na Resolução CVM 80.

Os membros do Conselho de Administração serão investidos nos seus cargos mediante assinatura, no prazo de 30 (trinta) dias contados da eleição, dos respectivos termos de posse, lavrados em livro próprio, em conformidade aos requisitos estabelecidos pela legislação aplicável, pelo Estatuto Social e pela Política de Indicação da Companhia, contendo: (a) a submissão à cláusula compromissória prevista no artigo 54 do Estatuto Social da Companhia e no artigo 39 do Regulamento do Novo Mercado da B3; (b) as declarações de desimpedimento, para os fins do artigo 147, § 4º, da Lei das S.A. e do artigo 46, § único e Anexo K, da Resolução CVM 80; e (c) com relação aos membros independentes, as declarações atestando seu enquadramento em relação aos critérios de independência estabelecidos no Anexo K da Resolução CVM 80 e na Política de Indicação da Companhia; e (d) a indicação de domicílio para o recebimento de citações e intimações relativas a processos administrativos e judiciais relacionados a atos de gestão.

Após a posse dos membros ora eleitos, o Presidente do Conselho de Administração será eleito na primeira reunião do Conselho de Administração a ser realizada imediatamente após a referida posse, nos termos do artigo 12, § 3º, do Estatuto Social da Companhia.

7. ENCERRAMENTO: Não havendo nada mais a tratar, o Presidente da Mesa declarou suspensos os trabalhos pelo prazo necessário à lavratura da presente ata que, lida e achada conforme, foi assinada pelos membros da mesa, sendo que os acionistas (i) cujos respectivos boletins de voto a distância foram considerados válidos pela Companhia ou (ii) que registraram a sua presença por meio da plataforma eletrônica disponibilizada pela Companhia tiveram sua presença registrada pelos membros da mesa no Livro de Presença de Acionistas da Companhia e foram considerados assinantes da presente ata, nos termos do artigo 47, §§ 1º e 2º, da Resolução CVM 81. **(aa) Mesa:** Alexandre Gonçalves Silva, Presidente; Nair V.
