











Market projections estimated revenue less than $\frac{3}{4}$ of what was actually achieved by the Management BU.


The 5-10 year CAGR of Management BU grows 1.2x more than the market itself, which in turn grows 2x the Nominal GDP.






24% growth in Recurring Revenue and 22% growth in Adjusted EBITDA , resulting in a 60 basis point y/y Margin expansion


