Ruth Cardoso, n.º 7221 Sala 8, CEP 05.425-902, atualmente detida pelas vendedoras, Linx S.A., inscrita no CNPJ/MF sob o n.º 06.948.969/0001-75 e STNE Participações S.A., inscrita no CNPJ/MF sob o n.º 35.767.420/0001-82.
7. **DELIBERAÇÕES:** após as discussões relacionadas à matéria constante da Ordem do Dia e a dispensa da leitura do mapa de votação sintético, que consolida os votos proferidos por meio dos boletins de voto a distância, o qual permaneceu à disposição dos acionistas presentes, nos termos do parágrafo único do artigo 46-C da Resolução CVM n.º 81/2022, foram tomadas as seguintes deliberações:
 - 7.1.1 Aprovar, por maioria dos acionistas votantes, tendo sido computados 458.796.817 votos a favor, 3.572 votos contrários e 5.321 abstenções, a aquisição, pela Companhia, nos termos do §1º do artigo 256 da Lei das S.A., de forma direta, da totalidade das ações representativas da integralidade do capital social da Linx, na forma e observados os termos e condições especificados na documentação definitiva já firmada e nos materiais submetidos à Assembleia.
