A **TOTVS S.A.** (B3: TOTS3) ("<u>TOTVS</u>" ou "<u>Companhia</u>"), em cumprimento ao disposto na Resolução CVM 44/2021, informa que recebeu, em 3 de março de 2025, correspondência ("<u>Correspondência</u>") do GIC Private Limited ("<u>GIC</u>"), na qualidade de representante do Governo e da Autoridade Monetária de Singapura (*Government of Singapore* and the *Monetary Authority of Singapore*), comunicando que, em 28 de fevereiro de 2025, o Governo de Singapura passou a deter, de forma isolada, 3,978% do total do capital social da TOTVS, equivalente a 23.845.909 ações ordinárias de emissão da Companhia ("<u>Ações Ordinárias</u>"). Assim, de forma agregada, a participação do GIC alcançou 4,851% do capital social da TOTVS, totalizando 29.077.918 Ações Ordinárias. A íntegra da Correspondência encontra-se a seguir.

O GIC informa, ainda, que a alienação da participação societária não visa alterar o controle acionário ou a estrutura administrativa da Companhia.

TOTVS S.A. (B3: TOTS3) ("TOTVS" or "Company"), in compliance with the provisions of CVM Resolution 44/2021, hereby informs that it received, on March 3rd, 2025, a correspondence ("Correspondence") sent by GIC Private Limited ("GIC"), representing the Government of Singapore and the Monetary Authority of Singapore, informing that, as of February 28th, 2025, the Government of Singapore now solely holds 3.978% of the capital stock of TOTVS, equivalent to 23,845,909 common shares of the Company ("Common Shares"). Thus, in aggregate, GIC interest reached 4.851% of the Company's capital stock, representing 29,077,918 Common Shares. The aforementioned Correspondence is attached to this notice.

GIC also informed that such disposal of material ownership does not aim to change neither the controlling interest nor the management structure of the Company.
