GIC informou ainda, que não tem interesse em alterar a composição do controle ou da estrutura administrativa da Companhia e que, além da participação acionária detalhada acima, não possuem outros valores mobiliários referenciados em tais ações e que não foram celebrados contratos regulando o exercício do direito de voto ou a compra e venda de valores mobiliários de emissão da CM HOSPITALAR S.A.


Furthermore, at the date hereof, we are not a party to any agreement or contract regulating the right to vote regarding the securities issued by CM HOSPITALAR S.A.
