I. Data, Hora e Local: Aos 26 dias do mês de abril de 2024, às 09h30, horário de Brasília, de modo exclusivamente digital por meio do sistema eletrônico de participação à distância, nos termos do artigo 124, § 2º-A da Lei nº 6.404, de 15 de dezembro de 1976 (“Lei das S.A.”), e do artigo 5º, §2º, inciso I da Resolução da Comissão de Valores Mobiliários (“CVM”) nº 81, de 29 de março de 2022 (“Resolução CVM 81”). Nos termos do artigo 5º, §3º da Resolução CVM 81, esta Assembleia Geral Ordinária e Extraordinária (“Assembleia”) da Natura &Co Holding S.A. (“Companhia”) foi considerada como realizada na sede social da Companhia, localizada na Avenida Alexandre Colares, nº 1.188, sala A17, bloco A, Parque Anhanguera, CEP 05106-000, na cidade de São Paulo, Estado de São Paulo.

II. Convocação: Edital de Convocação publicado exclusivamente por meio do Sistema Empresas.NET, conforme previsto na Resolução CVM nº 166, de 1 de setembro de 2022.

III. Publicações Legais: O Relatório da Administração e as Demonstrações Financeiras da Companhia, acompanhadas do Relatório dos Auditores Independentes elaborado pela PricewaterhouseCoopers Auditores Independentes Ltda., relativos ao exercício social encerrado em 31 de dezembro de 2023, juntamente com o Parecer do Conselho Fiscal sobre as Demonstrações Financeiras, e o Relatório Anual do Comitê de Auditoria, de Gestão de Riscos e de Finanças foram publicados em 11 de março de 2024 no Sistema Empresas.Net, divulgados nos websites da Companhia, da CVM e da B3 S.A. – Brasil, Bolsa, Balcão (“B3”) e arquivados na sede social da Companhia.

IV. Quórum: Presentes acionistas titulares de ações ordinárias, nominativas e sem valor nominal representativas de (i) 83,09% do total de votos conferidos pelas ações com direito a voto da Companhia em Assembleia Geral Ordinária; e (ii) 83,35% do total de votos conferidos pelas ações com direito a voto da Companhia em Assembleia Geral Extraordinária, conforme registros do sistema eletrônico de participação a distância, nos termos do artigo 47, inciso III da Resolução CVM 81, e informações constantes dos mapas analíticos elaborados pelo agente escriturador e pela própria Companhia, na forma do artigo 48, incisos I e II, da Resolução CVM 81.

V. Presença Legal: Presentes o Sr. Itamar Gaino Filho, Diretor Jurídico e de Compliance da Companhia, o Sr. Moacir Salzstein, Diretor de Governança Corporativa da Companhia, o Sr. Rodrigo Lobenwein Marcatti, representante da PricewaterhouseCoopers Auditores Independentes Ltda., o Sr. Gilberto Mifano, Presidente do Comitê de Auditoria, de Gestão de Riscos e de Finanças, o Sr. Carlos Elder Maciel de Aquino e a Sra. Cynthia May Hobbs Pinho, membros titulares do Conselho Fiscal, em atendimento ao disposto no §1º do artigo 134 e caput do artigo 164 da Lei das S.A.

VI. Composição da Mesa: Assumiu a presidência dos trabalhos o Sr. Henrique da Silva Gordo Lang, que convidou o Sr. Itamar Gaino Filho e o Sr. Moacir Salzstein para secretariarem os trabalhos.

VII. Leitura dos Documentos e Lavratura da Ata: Foi dispensada a leitura do Edital de Convocação e do Mapa Sintético de Votação Consolidado dos votos proferidos por mecanismo de voto a distância, divulgado ao mercado em 25 de abril de 2024, os quais ficaram à disposição para consulta dos acionistas presentes, nos termos do artigo 48, §4º, da Resolução CVM 81. Foi aprovada

pela unanimidade dos presentes a lavratura da presente ata em forma de sumário dos fatos ocorridos e a sua publicação com omissão das assinaturas dos acionistas, na forma do artigo 130, §§ 1º e 2º, da Lei das S.A.

VIII. Ordem do Dia: Deliberar sobre:

Em Assembleia Geral Ordinária:

(1) tomar as contas dos administradores, examinar, discutir e votar as demonstrações financeiras, acompanhadas do relatório dos auditores independentes, do relatório do Comitê de Auditoria, de Gestão de Risco e de Finanças e do Parecer do Conselho Fiscal relativos ao exercício social encerrado em 31 de dezembro de 2023;

(2) definir o número de membros do Conselho de Administração da Companhia;

(3) deliberar sobre a independência dos candidatos aos cargos de membros independentes do Conselho de Administração da Companhia;

(4) eleger os membros do Conselho de Administração da Companhia, para um mandato unificado de 2 (dois) anos; e

(5) fixar a remuneração global dos administradores da Companhia, a ser paga até a data da assembleia geral ordinária em que os acionistas da Companhia deliberarem acerca das demonstrações financeiras do exercício social a ser encerrado em 31 de dezembro de 2024.

Em Assembleia Geral Extraordinária:

(1) atualizar o artigo 5º do Estatuto Social da Companhia, de forma a refletir o capital social consignado na Reunião do Conselho de Administração realizada no dia 10 de outubro de 2023, e consolidar o Estatuto Social da Companhia.

VIII. Deliberações:

Em Assembleia Geral Ordinária:

(1) Foram aprovadas, por maioria dos votos proferidos, com as devidas abstenções dos legalmente impedidos de votar, tendo sido computados 505.316.898 votos a favor, 278.328 votos contrários e 95.431.263 abstenções, as contas dos administradores e as demonstrações financeiras da Companhia relativas ao exercício social encerrado em 31 de dezembro de 2023.

(2) Foi aprovada, por maioria dos votos proferidos, tendo sido computados 1.110.015.495 votos a favor, 35.372 votos contrários e 24.778.396 abstenções, a definição de que o Conselho de Administração da Companhia será composto de 9 (nove) membros.

(3) Foi aprovada, por maioria dos votos proferidos, tendo sido computados 1.107.040.576 votos a favor, 69.850 votos contrários e 27.718.575 abstenções, a caracterização de Andrew George McMaster Jr., Bruno de Araújo Lima Rocha, Carla Schmitzberger, Georgia Melenikiotou, Gilberto Mifano e Maria Eduarda Mascarenhas Kertész como candidatos a membros independentes do

Conselho de Administração da Companhia, nos termos do artigo 17 do Regulamento do Novo Mercado da B3.

(4) Foi aprovada, por maioria dos votos proferidos, tendo sido computados 1.070.969.628 votos a favor, 16.022.833 votos contrários e 47.835.132 abstenções, a reeleição dos membros indicados abaixo para compor o Conselho de Administração, com prazo de mandato unificado de 2 (dois) anos, que se encerrará na data de realização da assembleia geral ordinária em que os acionistas da Companhia deliberarem acerca das demonstrações financeiras do exercício social a ser encerrado em 31 de dezembro de 2025:

A Companhia informou que os conselheiros ora eleitos cumprem os requisitos de elegibilidade e que estão em condições de firmar termo de posse e prestar as declarações exigidas nos termos do Anexo K da Resolução CVM nº 80, de 29 de março de 2022, e do artigo 147 da Lei das S.A.

(5) Foi aprovada, por maioria dos votos proferidos, tendo sido computados 1.040.859.964 votos a favor, 66.205.465 votos contrários e 27.763.812 abstenções, a fixação da remuneração global dos administradores a ser paga até a data de realização da assembleia geral ordinária em que os acionistas da Companhia votarem acerca das demonstrações financeiras do exercício social a ser encerrado em 31 de dezembro de 2024, considerando o período de maio de 2024 a abril de 2025, no valor total de até R\$82.422.812,14, incluindo remuneração fixa, variável e baseada em ações.

(6) Tendo em vista o pedido de instalação de Conselho Fiscal por acionistas titulares de ações representativas de no mínimo 2% (dois por cento) das ações com direito a voto de emissão da Companhia, nos termos da Resolução CVM nº 70, de 22 de março de 2022, foi aprovada pelos acionistas minoritários, em eleição em separado, com 8.308.787 votos a favor, 0 votos contrários e 481.528 abstenções, a eleição de: **Cristina Fontes Doherty**, brasileira, separada judicialmente, economista, RG nº 063703268 Detran/RJ, CPF nº 803.661.047-72, com endereço comercial na Av. Dra. Ruth Cardoso, 8.501, 8º andar, conjunto 2, Pinheiros, São Paulo, SP, CEP 05425-070, como membro efetivo e, seu respectivo suplente, **Antônio Martinigo Filho**, brasileiro, casado, administrador, inscrito no CPF sob o nº 097.000.288-28, RG nº 17.114.372 SSP-SP, Endereço: Av. Dr. Silas Munguba, 5.700, bloco Cl-Térreo Passaré, CEP 60.743-902 — Fortaleza/CE.

O mandato dos membros do Conselho Fiscal ora eleitos se encerrará na data de realização da assembleia geral ordinária em que os acionistas da Companhia votarem acerca das demonstrações financeiras do exercício social a ser encerrado em 31 de dezembro de 2024.

Os acionistas que indicaram membros ao Conselho Fiscal informaram à Mesa que os respectivos conselheiros fiscais (i) possuem a qualificação necessária e cumprem os requisitos estabelecidos nos artigos 162 e 147 da Lei das S.A. para o exercício do cargo, e (ii) que estão em condições de firmar termo de posse contendo as declarações quanto ao cumprimento de tais requisitos e de assumir a responsabilidade pelo cargo nos termos da lei.

(7) Foi aprovada, por unanimidade dos votos proferidos, tendo sido computados 533.263.855 votos a favor, 0 votos contrários e 35.909.833 abstenções, a fixação da remuneração global dos membros do Conselho Fiscal ora eleitos, respeitando-se, para cada membro em exercício, o valor de 10% (dez por cento), em média, da remuneração atribuída aos Diretores da Companhia, não computados benefícios, verbas de representação e participação nos lucros, nos termos do parágrafo 3º do artigo

162 da Lei das S.A. Os membros suplentes dos membros do Conselho Fiscal somente serão remunerados quando atuarem em substituição aos membros efetivos.

Em Assembleia Geral Extraordinária:

Foi aprovada, por maioria dos votos proferidos, tendo sido computados 1.111.810.363 votos a favor, 62.000 votos contrários e 26.431.135 abstenções, a atualização do artigo 5º do Estatuto Social da Companhia de forma a refletir o capital social consignado na reunião do Conselho de Administração realizada no dia 10 de outubro de 2023, bem como a consolidação do Estatuto Social da Companhia. Deste modo, o *caput* do art. 5º passa a ter a seguinte nova redação:

“**Artigo 5º** – O capital social da Companhia, totalmente subscrito e integralizado, é de R\$12.697.285.074,75, (doze bilhões, seiscentos e noventa e sete milhões, duzentos e oitenta e cinco mil, setenta e quatro reais e setenta e cinco centavos), dividido em 1.386.848.066 (um bilhão, trezentos e oitenta e seis milhões, oitocentas e quarenta e oito mil, sessenta e seis) ações ordinárias nominativas, sem valor nominal.”

O texto do Estatuto Social consolidado da Companhia, ora aprovado conforme a proposta da administração, já contemplando a alteração indicada acima, foi autenticado pela Mesa, numerado e arquivado na sede da Companhia, e será levado a arquivamento na Junta Comercial do Estado de São Paulo em apartado a esta ata, bem como disponibilizado nos websites da CVM, da B3 e da Companhia.

IX. Encerramento: Nada mais havendo a tratar, o Presidente agradeceu a presença de todos e deu por encerrados os trabalhos, suspendendo a Assembleia para que se lavrasse a presente ata, a qual, depois de lida, discutida e achada conforme, foi aprovada e assinada pela Mesa. A lista dos Acionistas presentes consta do Anexo I. A Companhia registrou o recebimento da manifestação do acionista Caixa de Previdência dos Funcionários do Banco do Brasil - PREVI, que foi autenticada pela Mesa nos termos da lei e consta do Anexo II. Nos termos do artigo 47, §§1º e 2º da Resolução CVM 81, foram considerados presentes à assembleia e signatários da ata os acionistas cujos boletins de voto a distância foram considerados válidos pela Companhia e os acionistas que registraram a sua presença no sistema eletrônico de participação a distância.

I. Date, Time and Place: On April 26, 2024, at 9:30 a.m., Brasília time, exclusively online, with attendance through electronic system, in accordance with the provisions of article 124, paragraph 2-A of Law No. 6,404 of December 15, 1976 (the “Corporation Law”), and with article 5, paragraph 2, item I of Brazilian Securities Commission (“CVM”) Resolution No. 81, dated March 29, 2022 (“CVM Resolution 81”). In accordance with article 5, paragraph 3 of CVM Resolution 81, these Annual and Extraordinary General Meetings (the “General Meetings”) of Natura &Co Holding S.A. (the “Company”) were deemed held at the principal place of business of the Company, located at Avenida Alexandre Colares, nº 1.188, sala A17, bloco A, Parque Anhanguera, CEP 05106-000, in the City of São Paulo, State of São Paulo.

II. Call Notice: Call Notice published exclusively through the Empresas.NET System, as provided for in CVM Resolution No. 166, dated September 1st, 2022.

III. Legal Publications: The Company’s Management Report and Financial Statements, accompanied by the Independent Auditors’ Report prepared by PricewaterhouseCoopers Auditores Independentes Ltda., regarding the fiscal year ended December 31, 2023, together with the Fiscal Council’s Opinion on the Financial Statements and the Annual Report of the Audit, Risk Management and Finance Committee were published on March 11, 2024, on the Empresas.Net System, disclosed on the Company, CVM and B3 S.A. - Brasil, Bolsa, Balcão (“B3”) websites and filed at the Company’s principal place of business.

IV. Quorum: Shareholders holding common shares, registered and without par value, representing (i) 83.09% of the total votes conferred by the Company’s voting shares at the Annual General Meeting; and (ii) 83.35% of the total votes conferred by the Company’s voting shares at an Extraordinary General Meeting, as per records of the electronic participation system, pursuant to article 47, item III of CVM Resolution 81, and information contained in the analytical statements prepared by the bookkeeping agent and by the Company itself, pursuant to article 48, items I and II, of CVM Resolution 81.

V. Legal Attendance: Mr. Itamar Gaino Filho, Legal and Compliance Officer of the Company and Mr. Moacir Salzstein, Corporate Governance Officer of the Company, Mr. Rodrigo Lobenwein Marcatti, representative of PricewaterhouseCoopers Auditores Independentes Ltda., Mr. Gilberto Mifano, Chairman of the Audit, Risk Management and Finance Committee, Mr. Carlos Elder Maciel de Aquino and Mrs. Cynthia May Hobbs Pinho, full members of the Fiscal Council, in compliance with the provisions of paragraph 1 of Article 134 and the main section of Article 164 of the Corporation Law.

VI. Presiding Board: Mr. Henrique da Silva Gordo Lang took the role of chairman of the proceedings and invited Mr. Itamar Gaino Filho and Mr. Moacir Salzstein to act as secretaries.

VII. Reading of the Documents and Drafting of Minutes: The reading of the Call Notice and the Synthetic Consolidated Voting Ballot Map of the votes cast by remote voting mechanism, disclosed to the market on April 25, 2024, was waived, which were made available for consultation

by the shareholders present, pursuant to article 48, paragraph 4, of CVM Resolution 81. The drafting of these minutes in the form of a summary of the facts occurred was unanimously approved by those present, and its publication with the omission of the shareholders' signatures, pursuant to article 130, paragraphs 1 and 2, of the Corporation Law.

VIII. Agenda: To resolve on:

At the Annual General Meeting:

- (1) review the management accounts, examine, discuss, and vote on the financial statements, together with the report of the independent auditors, the Audit, Risk Management and Finance Committee's report, and the Opinion of the Fiscal Council, for the fiscal year ended on December 31, 2023;
- (2) define the number of members for the Company's Board of Directors;
- (3) resolve on the independence of the candidates for the positions of independent members of the Company's Board of Directors;
- (4) elect the members of the Company's Board of Directors, to serve for a unified mandate of two (2) years; and
- (5) define the global compensation of the Company's managers, to be paid until the date of the annual general meeting in which the Company's shareholders will vote on the financial statements for the fiscal year ending on December 31, 2024.

- (2) It was approved, by a majority of the votes cast, with a total count of 1,110,015,495 affirmative votes, 35,372 negative votes and 24,778,396 abstentions, the definition that the Company's Board of Directors will be composed of 9 (nine) members.
- (3) It was approved by majority of votes cast, with a total count of 1,107,040,576 affirmative votes, 69,850 negative votes and 27,718,575 abstentions, the characterization of Andrew George McMaster Jr., Bruno de Araújo Lima Rocha, Carla Schmitzberger, Georgia Melenikiotou, Gilberto Mifano and Maria Eduarda Mascarenhas Kertész as candidates for independent members of the Company's Board of Directors, as per article 17 of the Novo Mercado Rules of B3.
- (4) It was approved, by a majority of the votes cast, with a total count of 1,070,969,628 affirmative votes, 16,022,833 negative votes and 47,835,132 abstentions, the reelection of the members indicated

below to compose the Board of Directors, with a unified term of office will of two (2) years, which will end on the date of the annual general meeting during in which the Company's shareholders resolve on the financial statements for the fiscal year to be ended on December 31, 2025:

The member of the Fiscal Council hereby elected will all have a term of office which shall end on the date of the annual general meeting at which the Company's shareholders vote on the financial statements for the fiscal year ending on December 31, 2024.

The shareholders that have nominated any members to the Fiscal Council informed the Presiding Board that the respective fiscal council members (i) have the necessary qualification and fulfill the requirements established in articles 162 and 147 of the Corporation Law for the exercise of their position, and (ii) are in the position to sign the term of investiture with the statements regarding the fulfillment of such requirements and their ability to undertake their roles and assume responsibility for the positions pursuant to law.

(7) It was approved, by unanimity of the votes cast, with a total count of 533,263,855 affirmative votes, 0 negative votes and 35,909,833 abstentions, the setting of the overall remuneration of the members of the Fiscal Council hereby elected, respecting, for each member in office, the amount of 10% (ten percent), on average, of the remuneration attributed to the Company's Executive Officers, not counting benefits, representation fees and participation in profits, pursuant to paragraph 3 of article 162 of the Corporation Law. The alternate members of the Fiscal Council will only be remunerated when they act in place of the effective members.

At the Extraordinary General Meeting:

(1) It was approved, by a majority of the votes casted, with a total count of 1,111,810,363 affirmative votes, 62,000 negative votes and 26,431,135 abstentions, the update of article 5 of the

Company's Bylaws to reflect the current value of the share capital established at the Board of Directors' Meeting held on October 10, 2023, as well as the consolidation of the Company's Bylaws. Thus, the heading of article 5 now reads as follows:

“Article 5 - The Company's share capital, fully subscribed and paid up, is R\$12,697,285,074.75 (twelve billion, six hundred and ninety-seven million, two hundred and eighty-five thousand, seventy-four reais and seventy-five cents), divided into 1,386,848,066 (one billion, three hundred and eighty-six million, eight hundred and forty-eight thousand, and sixty-six) registered common shares without par value.”

The consolidated wording of the Company's Bylaws approved hereunder in accordance with the management's proposal, which already contemplates the items above, was authenticated by the Presiding Board, numbered and filed at the principal place of business of the Company and shall be filed with the Commercial Registry of the State of São Paulo separately from this minutes, as well as made available on the CVM, B3 and of Company's websites.

IX. Adjournment: There being nothing further to discuss, the Chairman thanked the presence of all attendants and ordered the adjournment of the general meetings after suspending the same so that these minutes could be drawn up, which, after being read, discussed and found to be in good order, were approved and signed by the Presiding Board. The list of Shareholders present is attached hereto as Exhibit I. The Company acknowledged receipt of the declaration of shareholder Caixa de Previdência dos Funcionários do Banco do Brasil - PREVI, which was authenticated by the Presiding Board pursuant to the law and is attached hereto as Exhibit II. In accordance with article 47, paragraphs 1 and 2 of CVM Resolution 81, the shareholders whose remote voting ballots were deemed valid by the Company and the shareholders who recorded their attendance on the electronic attendance system were deemed present at the meeting and signatories of the minutes.

Previ understands that the Fiscal Council represents best practices involving the implementation of ASG-ESG vectors (aspects related to the Company's environmental, social, and governance factors) and ensures the shareholders' right to oversee business management through the independent supervisory function of the Fiscal Council, reinforced by the individual actions of its members.

Furthermore, in line with article 7, item II, of CVM Resolution No. 81/22 and recommended by Circular/Annual Letter -2024-CVM SEP, to disclose information about candidates for the Board of Directors and Fiscal Council proposed by non-controlling shareholders, Previ recommends that in the next Annual General Meeting, Natura offer greater disclosure and transparency of any shareholder indicating candidates to compose its boards, unlike what was done this year after denying Previ's request to publicize its nominees."
